There is an additional fee for taking liquor aboard the coach, and coach parking fees are paid for by the group.

Department of Transportation Regulations dictates that a driver can only be on duty 15 hours in a day driving 10 hours, then must have full 8 hours off. If your charter requires more drive time than is legally allowed for a single driver, a second driver would be assigned to the charter at an additional charge.

## ***Policies***

Cheeseman Coaches Inc. prides itself on providing a clean, safe coach at all times. To maintain that high standard, we ask the customers to abide by these rules:

### ***Food and Non-alcoholic Drink Policy***

No dairy products of any kind are allowed on the coaches. This includes milk, milkshakes, ice cream, cappuccino drinks with whipped cream, milk, etc. Other food and drinks are allowed as long as the coaches are kept clean. At no time can liquids be put in overhead compartments. They may leak and get into VCR, DVD or other electronics and cause malfunctions. If cleanliness becomes a problem, the chartering party may be billed for a cleaning fee and/or this privilege may be revoked. No glass bottles on the coach at any time.

### ***Liquor Policy***

There is a \$150.00 extra charge for liquor on the coach. No glass bottles or kegs are allowed on the coach at any time. No Styrofoam coolers or coolers over 36 inches long. Cheeseman Coaches drivers have the right to check coolers for glass bottles. If glass is found in the cooler, the whole cooler goes beneath the coach, no questions asked. If someone brings alcohol on the coach and the chartering party has not paid the extra liquor charge, it is their (chartering party) responsibility to get it off the coach or be billed the extra charge.

Cheeseman Coaches, Inc. reserves the right to refuse transport of persons under the influence of drugs or liquor. It is the responsibility of the chartering party to control minor drinking.

### ***Important!!***

Any and all damage done to the coaches by the chartering party will be billed to the chartering party. Chartering groups must provide adequate supervision and discipline.

If something should get spilled, please inform the driver immediately so it can be cleaned up. Please put all cans and trash in waste cans which are provided to keep the coach looking nice at all times.

There is no smoking on coaches at any time. This is a Federal Law.
